The deadline to submit copy or photo of work to the Visual Arts Committee is Friday, January 19, 2024. You must submit a copy or photo of your work for consideration by the Visual Arts Committee by mail or email. ***Your entry should be new art not previously displayed in the Fine Arts Show.*** You will be notified promptly of your acceptance. This year we will limit the number of entries to a total of 100, so we recommend that you do not wait until the last day to submit your entry. There will be a maximum of **4** items per artist due to gallery space (*maximum 36" x 36" canvas size*). Total entry fee is \$25.00, and membership in the Acton Agua Dulce Arts Council (AADAC) is required. Non Members can pay an annual \$50 AADAC membership fee with their entry fee.

No late entries will be accepted.

Volunteers Required- The TAADAA Art Gallery is not always staffed, so volunteers will be needed to be present at the art show one day for 2 to 4 hours, depending on the number of participants. AADAC will coordinate with artists for what times they are available. Please let us know if you have a medical reason that would prevent you from being present at the art gallery.

Friday Feb 2 – drop off art between 9:00 am and noon.

Saturday Feb 10 – Artist/Patron Reception 7:00 PM - 8:30 PM

This evening is set aside *for you*, and you may invite two guests to view your work and enjoy the ambience of the evening. You'll meet Arts Council Patrons and enjoy appetizers and beverages (note: there will be a charge for the wine and beer).

Preparation: Selected hanging artwork **MUST** include a hanging wire (framed or finished edge canvas). We will **not** be able to hang your work without it (see framing instructions). The backside of the framed work may be visible when on display, so please have the backs neatly covered in black or brown paper. Your **name and exhibit title** must be listed on the back of the artwork; please neatly print in light pen or pencil, or use a label.

Selling and commission: you may sell your artwork at the show. The Arts Council requires a 10% commission. Make your check payable to the Acton-Agua Dulce Arts Council. **Buyers may not pick up the artwork before 3:00 p.m. on Sunday, February 25.**

Biography: Please include a brief typed biography so we may display it for those viewing the artworks. You may have previously submitted one, but we are updating our records and request current information. We will format the information for each artist for conformity. Please send with your art submissions. You may also bring your business cards and brochures for display.

Agreement: please review and sign the attached agreement/release prior to the show.

PRE-DELIVERY INSTRUCTIONS: Selected hanging artwork **MUST** include a hanging wire. We will **not** be able to hang your work without it. The backside of the framed work will be visible when on display, so please have the backs neatly covered in black or brown paper. Your **name and exhibit title** must be listed on the back of the artwork; please print in light pen or pencil.

Deliver to the TAADAA Gallery, on Friday, February 2 between 9:00 am and noon. Pick up artwork Monday Feb 26, after the show between 9am and 12pm or arrange for someone to pick it up for you. *Neither the Arts Council nor Picasso's Playmates are responsible for your artwork.*

ACTON-AGUA DULCE ARTS COUNCIL AGREEMENT WITH EXHIBITING ARTIST

Acton-Agua Dulce Arts Council agrees to take reasonable measures in order to safeguard the artwork to be presented. This is limited to providing a locked structure for the artwork when the exhibit is closed. In leaving your artwork with the Acton-Agua Dulce Arts Council at the TAADAA Art Gallery, you hereby release the Acton-Agua Dulce Arts Council and TAADAA Art Gallery from any responsibility for damage or theft to the artwork.

In consideration, including but not limited to the ability to show the art work at the Acton-Agua Dulce Arts Council event, I release the Acton-Agua Dulce Arts Council, their board members and volunteers from any and all claims, demands, liens, actions, suits, causes of action, obligations, controversies, debts, costs, attorney's fees, expenses, damages, judgments, orders, and liabilities of whatever kind or nature in law equity or otherwise, whether now known or unknown, suspected or unsuspected, and whether or not concealed or hidden, which have existed, or which do exist or which hereafter can, shall or may exist, based on any facts, regarding the art work left with the AADAC for display.

On the event, the above provision is held invalid, should liability exist, by the Acton-Agua Dulce Arts Council, their board members and volunteers, the parties agree that it is impossible to arrive at an exact value of the damages. Therefore, it is agreed that if liability exists, liquidated damages in the total sum of \$50.00 shall be the maximum amount to be paid to the artist by the Acton-Agua Dulce Arts Council.

SALE OF ARTWORK:

At the artist's sole discretion, he/she may choose to place the artwork for sale at the art exhibit. The artist has the sole responsibility to arrange for the display and pick up of the artwork. The Acton-Agua Dulce Arts Council will not be involved in the sales transaction. The buyer and seller of the artwork will be solely responsible for local, State and Federal taxes applicable (if any).

It is further agreed that at the conclusion of a sale obtained through the display of the artwork, the artist shall pay the Acton-Agua Dulce Arts Council ten percent (10%) of the gross selling price of said art work.
